RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest (the "**Release**") is made this 15th day of March 2007, by General Electric Capital Corporation, a Delaware corporation (the "**Secured Party**"), in favor of Diamond Innovations, Inc., a Delaware corporation (the "**Debtor**"). The Secured Party is acting in its capacity as Agent for Lenders as designated by the Credit Agreement dated as of December 31, 2003 by and among Debtor, Secured Party and other parties.

WHEREAS, reference is further made to a certain Trademark Security Agreement dated as of December 31, 2003 (the "**Security Agreement**"), between Secured Party and Debtor, which Security Agreement was recorded with the U.S. Patent and Trademark Office at, among other places, Reel/Frame 002774/0900;

WHEREAS, in connection with the Security Agreement, Debtor granted to Secured Party a continuing first priority security interest in all of Debtor's right, title and interest in, to and under the Trademark Collateral (as defined in the Security Agreement); and

WHEREAS, Debtor has fully paid the indebtedness owing under the Security Agreement, and Secured Party desires to release and discharge its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby releases any and all of its right, title and interest in, to and under the Trademark Collateral. A list of registered trademarks and trademark applications which comprise a portion of the Trademark Collateral are set forth on Schedule I hereto. Secured Party agrees to hereafter execute any such release documents or amendments to Schedule I as may be reasonably necessary to record or perfect the release of the security interest in any portion of the Trademark Collateral not listed on Schedule I.


