CONFIRMATORY ASSIGNMENT OF TRADEMARKS

ASSIGNOR ratifies and reaffirms *nunc pro tunc* the assignment to ASSIGNEE of the entire right, title and interest in and to the TRADEMARK together with the goodwill of the business associated with the TRADEMARK.


ASSIGNOR, does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representatives.

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, to record said assignment so as to show ownership of the TRADEMARK in the name of ASSIGNEE.

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK and registration herein assigned.
