**PLAN OF MERGER**

**CFI ProServices, Inc. ("CFI") was incorporated on the 6th day of March, 1987, pursuant to the Oregon Business Corporation Act, the provisions of which allow a parent corporation owning all of the outstanding shares of each class of a subsidiary corporation to merge the subsidiary into itself.**

**CFI owns all of the outstanding shares of the capital stock of Culverin Corporation ("Culverin"), a corporation incorporated under the laws of the State of Ohio.**

**Culverin shall be merged with and into CFI, with CFI being the surviving entity in the merger, and CFI shall assume all of the rights and liabilities of Culverin; and that the shares of Common Stock of Culverin owned by CFI shall be surrendered and cancelled in the merger.**

**The merger of Culverin into CFI shall become effective on December 31, 1997**
