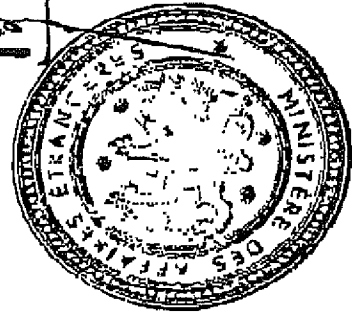

Agreement by and between

(A) Ciba Specialty Chemicals Holding Inc., Klybeckstrasse 141, CH-4002 Basel, Switzerland (SCH)

and

(B) Ciba Specialty Chemicals Oy, Raisalokaari 60, FI-21200 Raisio, Finland (OY)

and

(C) Ciba Specialty Chemicals Inc., Klybeckstrasse 141, CH-4002 Basel, Switzerland (SCO)

dated as of April 1, 2005

Whereas

(I) Ciba History

- (i) SCH is the registered and beneficial owner of most of the non-U.S. patents and patent applications within Ciba group;
- (ii) SCH is the registered owner of most of the trademarks of the Ciba group;
- (iii) With agreement dated June 25, 2002 between SCH and SCO, Ciba group trademarks have commenced to be registered in the name of SCO on a fiduciary basis on behalf of SCH;

(II) Raisio acquisition

- (i) With agreement dated June 2, 2004, between SCH and Raisio Group, SCH (together with certain of its affiliates) acquired Raisio Chemicals Oy (RCOY) and related businesses (the Raisio Business) from Raisio Group in the Transaction;
- (ii) On September 21, 2004, RCOY changed its company name into Ciba Specialty Chemicals Oy;

(III) IPR ownership and filing

- (i) Patents (SCH)
SCH and OY intend that the legal ownership all pending and granted patents of OY and of OY's affiliates be transferred to SCH; (including

those patents and patent applications that are part of the Transaction but have not yet been transferred from Raisio Group or Raisio affiliates)

SCH and OY intend that all new patent applications, which base on inventions made by OY or by a company which forms part of the Raisio Business be filed in the name of SCH as legal owner only, the beneficial ownership to remain with OY;

As an exception to the Research Agreement between SCO and Ciba Specialty Chemicals Corporation (**Ciba Corp**), all patents and patent applications in the U.S. will be filed in the name of Ciba Corp as legal owner only, the beneficial ownership to remain with OY.

(ii) **Trademarks (SCO)**

SCO and OY intend that legal ownership of all pending and registered trademarks of OY and of OY's affiliates be transferred to SCO as legal owner only, the beneficial ownership to remain with OY;

SCO and OY intend that all new trademarks in connection with or used for products made by OY or by a company which forms part of the Raisio Business be filed in the name of SCO as legal owner only, the beneficial ownership to remain with OY;

(IV) **Research**

OY shall conduct or have research conducted on its own account;

~~Now, therefore, the Parties agree as follows:~~

PATENTS

(1) **Transfer of existing patents**

OY shall transfer and cause its affiliates to transfer to SCH and to Ciba Corp, respectively, all pending and granted patents which currently stand in its own name or in the name of any of its affiliates.

(2) **New patents**

All new patent applications that arise from inventions made by OY or its

affiliates shall be filed and registered in the name of SCH and Ciba Corp, respectively.

(3) **Costs for patent transfers**

Costs associated with the transfer of patents as sub (1) above, shall be borne by OY remaining the beneficial owner of these patents.

(4) **Costs for patent applications, maintenance and defense**

Costs associated with the filing of patents applications as sub (2) above, the prosecution, the maintenance and defense of the patents and patent applications shall be borne by OY. OY shall directly receive and pay pertinent invoices.

(5) **Consideration**

As SCH and Ciba Corp will only become legal owners of the patents and as cost associated with the prosecution, the maintenance and defense thereof as well as the beneficial ownership remains with OY, no consideration shall be payable.

TRADEMARKS

(6) **Assignments of existing trademarks**

OY shall assign and cause its affiliates to assign to SCO all filed and registered trademarks which currently stand in its own name or in the name of any of its affiliates.

(7) **New trademarks**

All new trademark applications for products that are based on inventions made by OY or its affiliates shall be filed and registered in the name of SCO.

(8) **Costs for trademark assignments, applications, maintenance and defense**

Costs associated with the assignment, the filing of trademark applications, the maintenance and defense of the trademarks shall be charged by SCO to OY on a quarterly basis.

(9) **Consideration**


As SCH and Ciba Corp will only become legal owners of the trademarks and as

cost associated with the prosecution, the maintenance and defense thereof will be passed on to OY as well as the beneficial ownership remains with Oy, no consideration shall be payable.

(10) **Applicable law and jurisdiction**

Swiss Law shall be applicable. The Courts of Basel shall have jurisdiction.




