(vii) **Files and Records**. Originals or copies of all books, records, files, and papers, whether in hard copy or computer format, including, without limitation, engineering information, manuals and data, sales and advertising materials, sales and purchase correspondence, lists of present and former suppliers, and personnel and employment records;

(viii) **Other**. All prepaid rentals and other prepaid expenses; and all bonds, securities, and cash.

Seller hereby warrants to Buyer that Seller is the owner of said property, that said property is being transferred subject to all liens, charges, and encumbrances, that Buyer hereby accepts said property subject to all liens, charges, and encumbrances, and that to the extent such property is transferable, Seller has full right, power, and authority to sell said property and to make this bill of sale. ALL WARRANTIES OF QUALITY, FITNESS, AND MERCHANTABILITY ARE HEREBY EXCLUDED.
