TRADEMARK ASSIGNMENT

WHEREAS, Vita Licensing, Inc., a Delaware corporation, with an office at 300 Delaware Avenue, Suite 900, Wilmington, Delaware 19801 ("Assignor") has adopted, used, and is the owner of U.S. Trademark Registration No. 3,174,488 for ENDOSKELETON for orthopedic and surgical supplies and materials, namely, plates and vertebral and spinal implants composed of artificial materials (hereinafter "the Mark"); and

WHEREAS, Titan Spine LLC , a Delaware limited liability company, with an office at 512 Water Street, Sheboygan Falls, Wisconsin 53085 ("Assignee"), is desirous of acquiring all right, title, and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark;

NOW, THEREFORE, intending to be legally bound hereby, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby assign to Assignee all of its rights, title, and interest in and to the Mark, including any choses in action relating to the Mark and the right to bring suit for past infringement of the Mark, together with the good will of the business symbolized by the Mark, and the above-identified registration thereof; provided, however, that Assignee does not hereby assume any liabilities, obligations or commitments of Assignor with respect to the Mark existing or arising prior to February 15, 2007, whether absolute or contingent, known or unknown, except as may be provided in the Asset Purchase Agreement between the parties dated January 15, 2007 (the "Asset Purchase Agreement"); and further provided that the foregoing assignment is subject, in all respects, to the terms and conditions of the Asset Purchase Agreement, and all of the representations and warranties, covenants and agreements contained therein, all of which shall survive the execution and delivery of this document.


