RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of March 19, 2007 ("Effective Date") by and between **Bank of America, N.A., as successor by merger to FLEET NATIONAL BANK (which was formerly known as BankBoston, N.A.)**, a national banking association, with an office at 100 Federal Street, Boston, MA 02110, as Agent ("Agent"), and **Dura-Line Corporation (as successor in interest to Integral Conduit Corporation)**, a Delaware corporation, with an office at 835 Innovation Drive, Knoxville, TN 37932 (the "Assignor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Collateral Security and Pledge Agreement by and between Assignor and Agent dated June 5, 1999 (the "Trademark Security Agreement"), Assignor granted to Agent a continuing security interest in and to all of Assignor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Assignor (collectively, the "Trademarks"), including, without limitation, the trademark registrations and applications set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Assignor and Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Revolving Credit Agreement among JTP Industries, Inc. (the "Borrower"), certain Subsidiaries of the Borrower, the Agent, and certain other banking institutions, dated July 25, 1997 (the "Credit Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on September 14, 1999 at Reel 1959, Frame 0871; and

WHEREAS, Assignor has paid all of its outstanding indebtedness to Agent.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Agent represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks.
