**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS is dated as of March 19, 2007, from LaSalle Business Credit, LLC, a Delaware limited liability company, as agent for itself and various other lenders (the "Secured Party"), to New Creative Enterprises, Inc., an Ohio corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 9, 2004, made by the Grantor in favor of the Secured Party (as amended, restated, modified or supplemented and in effect from time to time, the "Trademark Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Secured Party in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 5, 2005, at Reel 3101 and Frame 0012; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in that certain Trademark listed on Schedule A hereto. The term "Trademark" shall have the meaning provided by reference in the Trademark Security Agreement.
2. Release of Security Interest. The Secured Party hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Secured Party in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
