TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made this 6 day of March, 2007, by WACHOVIA BANK, NATIONAL ASSOCIATION (the "Secured Party") in favor of A.P. DEAUVILLE, LLC (the "Grantor");

WITNESSETH

This Trademark Release shall be binding upon the Secured Party and its successors and assigns.
