- 1.2** all rights of action arising or accrued in relation to any of the above including, without limitation, the right to take proceedings and to seek and recover damages and seek other remedies for all past infringements.

2 Convention Filing Right

This Assignment includes the right (where applicable) to file applications under the Paris Convention, corresponding to or based on any applications for Marks, and to claim priority from those applications.

3 Further Assurance

Assignor agrees to execute such documents and provide such assistance as may be reasonably required by Assignee to obtain the full benefit of the assignment set out above.

4 Law and Jurisdiction

This Assignment shall be interpreted in accordance with English law and the courts of England shall have exclusive jurisdiction over any disputes arising from it.


