ASSIGNMENT OF TRADEMARKS

WHEREAS, Argonics wishes to acquire all right, title and interest in and to the Trademarks; and

NOW, THEREFORE, or and in consideration of \$10.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Pursuant to the Asset Purchase Agreement between the Parties of even date herewith (the "Agreement"), Kryptane hereby assigns to Argonics all right, title and interest that Kryptane may have in and to the Trademarks.
2. This Assignment of Trademarks may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
3. This Assignment of Trademarks is subject to all the terms and conditions of the Agreement.

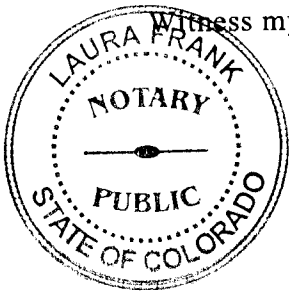
