WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to the Marks worldwide; and



In addition, ASSIGNOR assigns to ASSIGNEE all claims to recover for damages and profits for past, present or future infringements or other unauthorized use of the Marks, together with the right to sue for, and to collect, such damages.


