A MINNESOTA CORPORATION

These Articles of Merger relate to the merger of Condor Acquisition, Inc., a Minnesota corporation (the "Merged Corporation"), with and into Computer Network Technology Corporation, a Minnesota corporation (the "Surviving Corporation").

(a) Attached hereto as Exhibit A-1 is a true and correct copy of the Agreement and Plan of Merger dated as of January 17, 2005, among the Surviving Corporation, McDATA Corporation, a Delaware corporation ("McDATA"), and the Merged Corporation, as amended by Amendment No. 1 to Agreement and Plan of Merger dated as of February 10, 2005 among the Surviving Corporation, McDATA and the Merged Corporation, pursuant to which the Merged Corporation is to be merged into the Surviving Corporation (as amended, the "Agreement and Plan of Merger"); a true and correct copy of Amendment No. 1 is attached hereto as Exhibit A-2.

(b) The name of the Surviving Corporation shall be changed to McDATA Services Corporation. Pursuant to Section 3.01 of the Agreement and Plan of Merger, the Articles of Incorporation of the Surviving Corporation shall be amended and restated in their entirety to read as set forth in Exhibit B attached hereto.

(c) The Agreement and Plan of Merger was approved by a vote of the shareholders and the Board of Directors of each of the undersigned corporations, in the manner prescribed by Minnesota Statutes, Section 302A.613.

(d) These Articles of Merger shall be effective as of 12:01 a.m. on June 1, 2005.

These Articles of Merger are dated as of May 31, 2005.
