**CERTIFICATE OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF
GENOSPECTRA, INC.
a California corporation**

The undersigned, Frank Witney and Mark TenBoer, hereby certify that:

1. They are the President and Secretary, respectively, of Genospectra, Inc., a California corporation (the "Corporation").

2. Article I of the Seventh Amended and Restated Articles of Incorporation of the Corporation is amended and restated to read in its entirety, as follows:

"The name of this corporation is Panomics, Inc. (the "Corporation")."

3. This Certificate of Amendment has been duly approved by the Board of Directors.

4. This Certificate of Amendment was duly approved by the holders of the requisite number of shares of said corporation in accordance with Sections 902 and 903 of the Corporations Code; the total number of outstanding shares of each class entitled to vote with respect to the foregoing amendment was 4,113,120 shares of Common Stock, 251,692 shares of Series A-1 Preferred Stock, 806,927 shares of Series B1-1 Preferred Stock, 286,511 shares of Series B2-1 Preferred Stock, 27,574,786 shares of Series C Preferred Stock and 12,686 shares of Series Z Preferred Stock. The number of shares voting in favor of the foregoing amendment and restatement equaled or exceeded the vote required, such required vote being a majority of the outstanding shares of Common Stock and Preferred Stock, voting together as a single class on an as-converted to Common Stock basis and at least sixty-six and two-thirds percent (66 2/3%) of the outstanding shares of Series A-1 Preferred Stock, Series B1-1 Preferred Stock, Series B2-1 Preferred Stock, and Series C Preferred Stock, voting together as a single class on an as-converted to Common Stock basis.
