WHEREAS, **CHALLENGER PARTNERS** desires to obtain the legal title to said trademark;



ALL OF THE SAME to be held and enjoyed by said **CHALLENGER PARTNERS** for its own use and behoof and for its successors, assigns and legal representatives as fully and entirely as the same would have been held and enjoyed by said **FAIRPORT MARINE** had this Assignment not been made.
