Whereas, "COADE, Inc." is listed as the registered owner of the trademarks appearing in the attached Schedule A.


Whereas, the name "COADE, Inc." is a fictitious business name under which Engineering Physics transacts business.

Whereas, Engineering Physics wishes to assume ownership of the trademark registrations listed in the attached Schedule A in its own name.


