**TERMINATION OF SECURITY AGREEMENT AND RELEASE
(TRADEMARKS)**

WHEREAS, ProQuest Business Solutions, Inc. was a party to a security agreement with LaSalle Bank Midwest National Association, formerly known as Standard Federal Bank, N.A., a national banking corporation ("Grantee"), dated April 26, 2006, and granted a security interest in the federal trademark application in the United States Patent and Trademark Office, more particularly described in Schedule 1 annexed hereto and made a part hereof (the "Trademark Application"), which security interest is recorded at Reel 3302, Frame 0597;

WHEREAS, ProQuest Business Solutions, Inc. assigned all of its right, title, and interest in and to the Trademark Application to ProQuest Information and Learning, LLC, a limited liability company organized under the laws of Delaware, having an address at 789 E. Eisenhower Parkway, P.O. Box 1346, Ann Arbor, MI, 48106 (the "Grantor"), which assignment, dated October 18, 2006, is recorded at Reel 3411, Frame 0883;

WHEREAS, the Grantor owns all right, title, and interest in and to the Trademark Application;

WHEREAS, the security interest in the Trademark Application granted by the Grantor, and currently held by Grantee, was to secure the prompt payment, performance, and observance of certain obligations of Grantor (the "Obligations");

WHEREAS, the Grantor's Obligations have been discharged; and

WHEREAS, the parties hereto desire to terminate the agreements under which the security interest in and to the Trademark Application was granted, and Grantee agrees to formally release and re-convey to the Grantor such security interest;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantee hereby: (A) terminates the security interest in the Trademark Application as recorded in the U.S. Patent and Trademark Office on May 4, 2006, at Reel 3302, Frame 0597; and (B) terminates, cancels, releases and re-conveys the Grantor any and all security interest held by Grantee in and to the Trademark Application.

Grantee hereby further agrees to take any and all further actions, and to execute and deliver, and to provide Grantor, its successors, assigns or other legal representatives, any and all such documents or other instruments, reasonably requested by the Grantor to evidence, give effect to and perfect the release of the security interest hereunder and the termination of the security agreement referenced above.

IN WITNESS WHEREOF, Grantee has caused this agreement to be duly executed by its officer thereunto duly authorized as of the 19 day of March, 2007.
