- a) vote at all meetings of shareholders and on every poll taken at every such meeting, or adjourned meeting, every holder of Common Shares shall be entitled to one vote in respect of each Common Share held; and
- b) to receive the remaining property of the Corporation upon a dissolution; and
- c) to receive all dividends declared by the Corporation.

11. The issue, transfer or ownership of shares is/is not restricted and the restrictions (if any) are as follows:

The right to transfer shares of the Corporation is restricted and no shares shall be transferred without the consent of the Directors of the Corporation expressed by a resolution passed by the Board of Directors.

1. Without limiting the borrowing powers of the Corporation as set forth in the Ontario Business Corporations Act, and in its By-Laws, the Board of the Corporation may from time to time:

- a) borrow money upon the credit of the Corporation;
- b) issue, re-issue, sell or pledge bonds, debentures, notes or other evidence of indebtedness or guarantee of the Corporation, whether secured or unsecured; and
- c) charge, mortgage, hypothecate, pledge or otherwise create a security interest in all or any currently owned or subsequently acquired real or personal, movable or immovable property of the Corporation, including book debts, rights, powers, franchises and undertaking, to secure any such bonds, debentures, notes or other evidence of indebtedness or guarantee or any other present or future indebtedness or liability of the Corporation.

The Board may from time to time delegate to such one or more of the Directors and Officers of the Corporation as may be designated by the Board all or any of the powers conferred on the Board by the foregoing or by the Ontario Business Corporations Act, to such extent and in such manner as the Board shall determine at the time of each such delegation. Nothing in this provision limits or restricts the borrowing of money by the Corporation on bills of exchange or promissory notes made, drawn, accepted or endorsed by or on behalf of the Corporation.

2. The number of shareholders of the Corporation shall be limited to not more than 50 persons, not including persons who are in the employment of the Corporation and persons who, having been formerly in the employment of the Corporation were, while in that employment, and have continued to be after the termination of that employment, shareholders of the Corporation, two or more persons who are the joint registered owners of one or more shares being counted as a single shareholder.

3. Any invitation to the public to subscribe for any shares or securities of the Corporation is prohibited.

13. The corporation has complied with subsection 180(3) of the Business Corporations Act.
