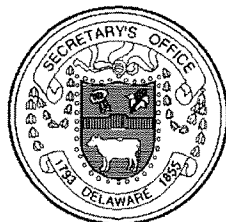

It is hereby certified that:

1. The constituent business entities participating in the merger herein certified are:
 - (i) Rotex, Inc., a corporation organized under the laws of the State of Ohio (the "**Merging Corporation**"); and
 - (ii) Rotex Acquisition, LLC, a limited liability company organized under the laws of the State of Delaware (the "**Surviving Company**").
2. An Agreement and Plan of Merger (the "**Merger Agreement**") has been approved and executed by each of the Merging Corporation and the Surviving Company in accordance with the laws of the State of Ohio and the provisions of Section 18-209 of the Limited Liability Company Act of the State of Delaware.
3. As of the effective time of the Merger Agreement, the name of the Surviving Company shall be changed to: "Rotex Global, LLC".
4. As of the effective time of the Merger Agreement, the Certificate of Formation of the surviving company shall be the Certificate of Formation of the Surviving Company, as amended to reflect the change in the Surviving Company's name (from "Rotex Acquisition, LLC" to "Rotex Global, LLC") described above. Such amendment shall be effected by deleting Article First of the Certificate of Formation of the Surviving Company in its entirety and replacing it with the following:

"FIRST. The name of the limited liability company formed hereby is Rotex Global, LLC."
5. The executed Merger Agreement is on file at the principal place of business of the Surviving Company, which is located at: 1230 Knowlton Street, Cincinnati, Ohio 45223. A copy of the Merger Agreement will be furnished by the Surviving Company, upon request and without cost, to any member or other person holding an interest in either of the constituent business entities.
