## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is made this 16<sup>th</sup> day of APRIL, 2006, by and between Lin Pac, Inc. (n/k/a U.S. Corrugated, Inc.) ("Assignor") and Lee Harris Farms ("Assignee").

### RECITALS:

WHEREAS, for a sum of \$10.00 and other valuable consideration, Assignor desires to assign to Assignee all of its right, title and interest in and to the trademark set forth on Exhibit A attached hereto (the "Mark"), and Assignee desires to accept such assignment from Assignor;

WHEREAS, the parties desire to enter into this Agreement to set forth the terms and conditions upon which such assignment shall be effected.


NOW, THEREFORE, in consideration of the mutual covenants herein, the parties hereto agree as follows:

1. Assignment of Rights. Assignor hereby assigns to Assignee all of its right, title and interest in and to the Mark and all goodwill associated therewith.
2. Disclaimer of Warranties. The Mark is being sold, conveyed, transferred and assigned "AS IS" and Assignor makes no representations or warranties concerning the quality of the Mark. ASSIGNOR MAKES NO WARRANTIES, EXPRESS OR IMPLIED, CONCERNING THE MARK, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
3. Severability. Should any part of this Agreement for any reason be declared invalid by a court of competent jurisdiction, such decision or determination shall not affect the validity of any remaining portion, and such remaining portion shall remain in force and effect as if this Agreement had been executed with the invalid portion eliminated; provided, that in the event of a declaration of invalidity the provision declared invalid shall not be invalidated in its entirety, but shall be observed and performed by the parties to the extent such provision is valid and enforceable.
4. Counterparts. This Agreement may be executed in one or more counterparts, each of which when so executed and delivered shall be deemed to be an original, and all of which taken together shall constitute one and the same instrument.
5. Governing Law. This Agreement shall be governed by and interpreted in accordance with the laws of the State of Georgia without regard to the conflicts of law provisions thereof. The parties hereby submit to the jurisdiction of the courts located in the State of Georgia for the purposes of all legal proceedings arising out of or relating to this Agreement or the transactions contemplated hereby.



