THIS DEED OF ASSIGNMENT is made on the day of 15 March 2007

BETWEEN:

- (1) **GLOBAL OBJECTIVES LIMITED**, a company incorporated in England and Wales whose registered office is at Tennyson House, 159 Great Portland Street, London W1W 5PA (registered no. 4098610) ("**Global**"); and
- (2) **GLOBAL WORLD-CHECK**, a company incorporated in England whose registered office is at 41 Chalton Street, London NW1 1JD (registered no. 06091589) (the "**Assignee**"),

(together the "**Parties**")

WHEREAS:

- (A) Global is the registered proprietor of the Registered Trade Marks and Domain Name, as defined below and owns rights arising from use of certain Trade Marks.
- (B) Global wishes to assign to Global World-Check all of its right, title and interest to the Registered Trade Marks, Domain Name and its rights arising from use of certain Trade Marks.

NOW IT IS AGREED as follows:

1. Definitions and Interpretation

- 1.1 In this Deed, unless the context requires otherwise the following expressions shall have the following meanings:

" Deed "	means this deed of assignment;
" Domain Name "	means the domain name as set out in Part 2 of Schedule 1;
" Encumbrance "	includes (without limitation) any mortgage, charge (fixed or floating), pledge, hypothecation, lien, option, right to acquire, assignment by way of security, trust arrangement for the purpose of providing security or any other security or third party interest of any kind, (including (without limitation) any imposed by law) and any proprietary interest or equity of any person including (without limitation) any title retention, option or right of pre-emption or any agreement for the same;
" Registered Trade Marks "	means the registered trade marks as set out in Schedule 1:
" Trade Marks "	means:

- (a) the expression "WORLD-CHECK" or any variant thereof; and
- (b) any and all logos, slogans or signs used in connection with the expression "WORLD-CHECK" by Global.

1.2 The headings in this Deed are for convenience only and shall not affect the interpretation of this Deed.

1.3 Unless the context otherwise requires, references to clauses are to clauses of this Deed.

2. Assignment

2.1 To the extent that Global has any right, title or interest in the Registered Trade Marks, the Trade Marks, the Domain Name or any goodwill associated with the use thereof, Global hereby assigns to the Assignee absolutely with full title guarantee and free of any Encumbrance:

2.1.1 all of its right, title and interest in respect of the Registered Trade Marks;

2.1.2 all of its rights arising from the use of the Trade Marks;

2.1.3 all of its rights in respect of all goodwill associated with the use of the Registered Trade Marks and/or the Trade Marks; and

2.1.4 the right to sue and recover damages and other remedies in respect of past, present or future infringements of the foregoing rights.

3. Further Assurance

3.1 Global shall execute such further documents and do such further acts as the Assignee may reasonably request in writing from time to time to vest in the Assignee all rights assigned to the Assignee under this Deed and to give Assignee the full benefit of this Deed.

4. Governing Law

This Deed shall be governed by and construed in accordance with the law of England and Wales. Each party hereby irrevocably submits to the exclusive jurisdiction of the courts of England and Wales over any claim or matter arising under or in connection with this Deed.

5. Counterparts

This Deed may be executed in any number of counterparts, but shall not be effective until each party has executed at least one counterpart. Each counterpart shall constitute an original of this Deed, but all counterparts shall together constitute but one and the same instrument.


