ASSIGNMENT OF TRADEMARKS

This Assignment of Trademark Rights, which shall be fully effective and legally binding as of March 21, 2007, is made by and between PET ANGEL MEMORIAL CENTER, INC., an Indiana corporation having a principal place of business at 172 East Carmel Drive, Carmel, Indiana, hereinafter referred to as "ASSIGNOR," and GELINAS-HANSON, LLC, a Delaware limited liability with a usual address of P.O. Box 878, Wilbraham, Massachusetts 01095, hereinafter referred to as "ASSIGNEE."

WHEREAS, ASSIGNOR currently owns all rights, title, and interest in U.S. Trademark Registration Nos. 3,047,897 for "Pet Angel Memorial Center"; 3,159,495 for "Remembering Life's Unconditional Love"; and 3,136,303 for "Paws in Time" (collectively referred to herein as the "Marks");

WHEREAS, ASSIGNEE is desirous of acquiring the entire right, title, and interest in the Marks;


NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and which is set forth in an Asset Purchase Agreement executed by authorized agents of the ASSIGNOR and ASSIGNEE on March 21, 2007, and which is attached herewith as Exhibit A, ASSIGNOR does hereby assign to ASSIGNEE all of ASSIGNOR's right of ownership to the Marks including all right, title and interest in and to the Marks including the goodwill of the business symbolized by the Marks and the right to re-assign the Marks.
