**Re: Payoff of Indebtedness and Lien Release**

Ladies and Gentlemen:

Bank of America, N.A. (the "Agent") refers to the Credit Agreement dated as of April 29, 2005, (the "Credit Agreement") among Synagro Technologies, Inc., a Delaware corporation (the "Borrower"), the Lenders and other financial institutions from time to time party thereto (the "Lenders"), Bank of America, N.A., as Administrative Agent, Issuing Lender and Swingline Lender and Banc of America Securities LLC and Lehman Brothers Inc., as Joint Lead Arrangers and Joint Book Managers. The undersigned has been advised by the Borrower that the Borrower intends to repay in full its obligations under the Credit Agreement (such obligations, including the Loans, being referred to herein as the "Debt"). Terms used and not otherwise defined herein shall have the meaning assigned to them in the Credit Agreement.

The total aggregate principal balance, unpaid accrued interest and other amounts, if any, due the undersigned under the Credit Agreement, if paid on April 2, 2007 (assuming no change in the interest rate and no further borrowings between the date hereof and such date) will be as follows (collectively, the "Payoff Amount"):

The undersigned acknowledges and agrees that, upon receipt by the undersigned of payment in full of, the Payoff Amount, other than fees due under section 3.05 of the Credit Agreement, together with any additional Per Diem Amounts:

(f) the Borrower, each Guarantor, their counsel and any designee of any thereof are hereby authorized and directed, without further notice, to file; and the Administrative Agent will immediately:

(i) execute and deliver to the Borrower or its counsel or designee releases of all security filings in the Patent and Trademarks or Copyright Office filed in favor of the Administrative Agent or the Lenders in connection with the transactions contemplated by the Credit Agreement, including releases (x) of the filings described in Exhibit A hereto, (y) the filings in respect of Patents described in Exhibit A(i) and (z) the filings in respect of Trademarks described in Exhibit A(ii);

(ii) file and deliver to the Borrower or its counsel or designee releases of all liens, including, without limitation, Uniform Commercial Code financing statement amendments, that are necessary to release all security interests and liens which the Borrower, any Guarantor or any other obligor has granted to the Administrative Agent or any Lender, without the signature of the Administrative Agent or any Lender, to the extent permitted by law; and

(iii) deliver or return to the Borrower or its counsel or designee any other Collateral in the Administrative Agent's possession.

The Administrative Agent agrees that, at any time and from time to time, it will promptly execute and deliver such other termination statements or other agreements and instruments in form and substance reasonably satisfactory to the Borrower, any Guarantor or any other obligor or designee, as the Borrower or such Person may reasonably request to further evidence and effect the release of the security interests and liens granted to the undersigned pursuant to the Credit Agreement, the other Loan Documents or any other agreement executed and delivered in connection therewith. Further, the undersigned hereby represents and warrants that it has not sold, transferred, assigned or otherwise encumbered any of the security or its interests in the assets of the Borrower, any Guarantor or any other obligor.



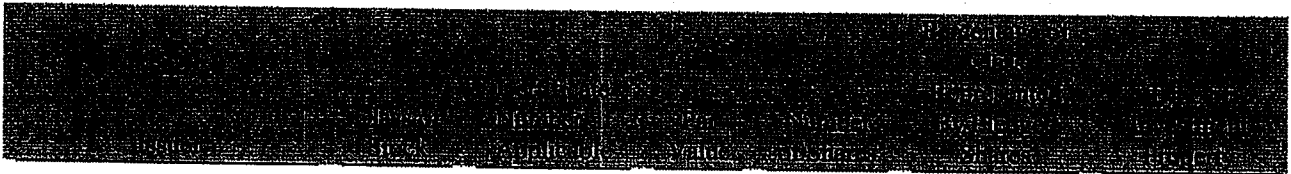

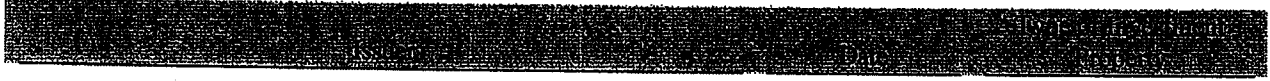
