RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of March 30, 2007 ("Effective Date") by MERRILL LYNCH CAPITAL, a division of Merrill Lynch Business Financial Services Inc., in its capacity as Administrative Agent ("Grantee"), pursuant to that certain Credit Agreement dated as of August 29, 2005, among Grantor (as defined below), St. Louis Music, Inc., Grantee and certain financial institutions from time to time party thereto as lenders ("Lenders"), in favor of LOUD TECHNOLOGIES, INC., a Washington corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of August 29, 2005 (the "Trademark Security Agreement"), by and among Grantor and Grantee, Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, for its benefit and the benefit of the Lenders, a security interest and mortgage in all of Grantor's right, title and interest in and to the Trademark Collateral (as such term is defined therein);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 30, 2005, as Reel 3149, Frame 0937;


WHEREAS, Grantee desires to release its Lien in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule A hereto:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Trademark Collateral, including, without limitation, the Trademark Collateral granted pursuant to the Trademark Security Agreement, or any loan document, is hereby terminated and released.
2. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are reasonably required in order to effectively carry out the purposes of this Release.
