RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of March 30, 2007 ("Effective Date") by WACHOVIA BANK, NATIONAL ASSOCIATION successor by merger to CONGRESS FINANCIAL CORPORATION, (FLORIDA), as Agent ("Grantee"), in favor of LOUD TECHNOLOGIES, INC., a Washington corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Collateral Assignment and Security Agreement dated as of September 15, 2003 (the "Security Agreement"), by and among Grantor and Grantee, as agent for the Lenders, as such term is defined in the Security Agreement, Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest and mortgage in all of Grantor's right, title and interest in and to the Trademark Collateral (as such term is defined therein);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 15, 2004, as Reel 2989, Frame 0744;


WHEREAS, Grantee desires to release its Lien in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule A hereto:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Trademark Collateral granted pursuant to the Security Agreement is hereby terminated and released.
2. Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to the Trademark Collateral, including without limitation the entire right, title and interest in and to the Trademark Collateral, including without limitation all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world and the goodwill of the business to which the Trademark Collateral relates.
