ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this "*Assignment*") is made as of March 30, 2007 by CBS Radio Stations Inc., a Delaware corporation ("*Seller*"), to Peak Broadcasting of Fresno, LLC, a Delaware limited liability corporation ("*Buyer*").

WHEREAS, Seller with a place of business at 1515 Broadway, 46th Floor, New York, New York 10036, is the owner of registrations for the trademarks that are identified in Schedule A ("*Marks*") on and in connection with the classes of goods/services as identified in Schedule A and desires to assign all of its right, title and interest in, to and under the Marks, together with the goodwill and business symbolized thereby; and

WHEREAS, Buyer, with a place of business at 1071 West Shaw Avenue, Fresno, California 93711, desires to obtain all of Seller's rights in, to and under the Marks; and

WHEREAS, pursuant to that certain Asset Purchase Agreement (the "*Purchase Agreement*"), dated as of November 16, 2006, between Seller and Buyer's parent company, Peak Broadcasting, LLC, a Delaware limited liability company ("*Peak*"), as assigned by Peak to Buyer and Peak Broadcasting of Fresno Licenses, LLC, a Delaware limited liability company, pursuant to that certain Assignment and Assumption Agreement dated January 18, 2007, Seller has agreed to assign all of its right, title and interest in, to and under the Marks to Buyer, and Buyer has agreed to accept such assignment.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Purchase Agreement, Seller hereby sells, assigns, transfers and conveys to Buyer all of Seller's right, title and interest in, to and under the Marks, and the goodwill associated therewith, whether statutory or at common law, including all registrations and applications therefor, the right to recover for past infringement, and the goodwill associated with such Marks in the operation of the business of radio broadcast stations.


