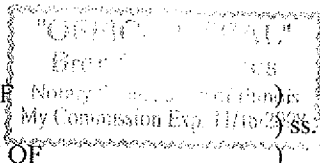
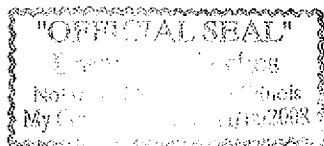

ASSIGNOR agrees to cooperate with ASSIGNEE, at ASSIGNEE's expense, to provide documents and information, which in ASSIGNEE's reasonable discretion, may be necessary or desirable to maintain, protect or enforce the trademark and registration therefor throughout the world. These obligations of assistance by ASSIGNOR shall survive closing related to the Agreement and shall continue for so long as ASSIGNEE may require such assistance from ASSIGNOR.
