**RELEASE OF SECURITY INTEREST IN
TRADEMARKS AND OTHER INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS AND OTHER INTELLECTUAL PROPERTY COLLATERAL (this "Release") is made as of March 30, 2007, and is granted by Wachovia Bank, National Association, as agent (the "ABL Agent") for the ABL Lenders, and Wachovia Bank, National Association, as collateral agent (the "Senior Note Collateral Agent") for the Note Holders (the ABL Agent and the Senior Note Collateral Agent being, together, the "Agents"), in favor of Olympic Foods, Inc., a Washington corporation ("OFI").

A. The ABL Agent (as successor to The CIT Group/Business Credit, Inc.), the Senior Note Collateral Agent, OFI and Darigold, Inc., a Washington corporation ("Darigold" and, together with OFI, the "Companies"), are parties to the Grant of Security Interest in Patents, Trademarks and Licenses, dated as of June 20, 2001, between Darigold and The CIT Group/Business Credit, Inc., as Agent, as amended and otherwise modified by the First Amendment to Grant of Security Interest in Patents, Trademarks and Licenses and Confirmation, dated as of June 3, 2004, between Darigold and the ABL Agent, as further amended and otherwise modified by the Second Amendment to Grant of Security Interest in Patents, Trademarks and Licenses and Confirmation, dated as of September 20, 2005, between Darigold and the ABL Agent, and as further amended and otherwise modified by the Third Amendment to Grant of Security Interest in Patents, Trademarks and Licenses and Confirmation, dated as of June 28, 2006 (the "Third Amendment"), among the Companies and the Agents (such Grant of Security Interest in Patents, Trademarks and Licenses, as so amended and otherwise modified, being the "Intellectual Property Security Agreement"; each capitalized term used in this Release and not otherwise defined shall have the meaning ascribed to such term in the Intellectual Property Security Agreement), pursuant to which Companies granted to the Agents, on behalf of the Agents and the Lenders, a security interest in, among other things, the registered trademarks owned by OFI and listed on Schedule A attached to this Release and by this reference incorporated in this Release (collectively, the "OFI Trademarks"), the goodwill associated with the OFI Trademarks, and other Intellectual Property Collateral owned by OFI; and

B. The Third Amendment was recorded at the United States Patent and Trademark Office at Reel and Frame No.: 3342/0667 on July 6, 2006; and

C. The Agents desire to release their security interests and rights in the OFI Trademarks and the other Intellectual Property Collateral owned by OFI;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged by the Agents:


1. The Agents, for and on behalf of themselves and the Lenders, hereby release and fully discharge, without representation or warranty, the security interest created by the Intellectual Property Security Agreement in and to the OFI Trademarks, the goodwill associated with the OFI Trademarks, all license royalties with respect to the OFI Trademarks, all claims for

damages, profits and proceeds by reason of past, present and future infringements and all rights to sue therefor, all rights corresponding thereto, all other Intellectual Property Collateral owned by OFI, and all proceeds of the foregoing, including, without limitation, license royalties and proceeds of suit.


2. The Agents acknowledge and agree that each power of attorney granted in the Intellectual Property Security Agreement is hereby terminated with respect to, but only with respect to, the OFI Trademarks and the other Intellectual Property Collateral owned by OFI.
