DESCRIPTION OF MARK:

THE COLORS RED AND BLUE ARE CLAIMED AS FEATURE OF THE MARK. THE MARK CONSISTS OF A BULL STANDING ON FOUR FEET. THE COLOR OF THE BULL IS RED.
