## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of March 30, 2007 ("Effective Date") by U.S. BANK NATIONAL ASSOCIATION, a New York corporation ("Grantee"), in favor of LOUD TECHNOLOGIES, INC., a Washington corporation (as assignee of SIA Software Company, Inc., a New York corporation) ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement dated as of April 6, 2000 (the "Security Agreement"), by and among Grantor and Grantee, as agent for the Lenders, as such term is defined in the Security Agreement, Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest and mortgage in all of Grantor's right, title and interest in and to the Collateral (as such term is defined therein);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on May 15, 2000, as Reel 2083, Frame 0960;

WHEREAS, Grantee desires to release its Lien in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule A hereto:

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Collateral, including, without limitation, the Trademark Collateral granted pursuant to the Security Agreement, or any loan document, is hereby terminated and released.
2. Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Trademark Collateral, including without limitation the entire right, title and interest in and to the Trademark Collateral, including without limitation all renewals thereof, all proceeds of infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world and the goodwill of the business to which the Trademark Collateral relates.
3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release.
