**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 3, 2007, is made by Credit Suisse, Cayman Islands Branch, as collateral agent under the Security Agreement (as described below) (in such capacity, the "Collateral Agent"), in favor of Pescor Plastics, Inc. ("Pescor Plastics") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Security Agreement, dated September 20, 2006 ("Security Agreement"), and recorded with The United States Patent and Trademark Office on September 22, 2006 at Reel/Frame No. 3395/0698, Pescor Plastics granted the Collateral Agent a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefore, including goodwill as described more fully in the Security Agreement (the "Trademark Collateral");

WHEREAS, the Collateral Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement have been made upon receipt of the funds described in the payoff letter dated the date hereof between Credit Suisse, Cayman Islands Branch and Pescor Plastics, Inc.;

WHEREAS, Pescor Plastics has requested that the Collateral Agent release its security interest in and to the trademarks and all applications and registrations therefore, including goodwill, set forth in Schedule A.




