**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of April 3, 2007, is made by Credit Suisse, Cayman Islands Branch, as collateral agent under the Security Agreement (as described below) (in such capacity, the "Collateral Agent"), in favor of Landis Plastics, Inc. ("Landis Plastics") as follows:

WITNESSETH

WHEREAS, pursuant to the Security Agreement, dated September 20, 2006 ("Security Agreement"), and recorded with The United States Patent and Trademark Office on September 22, 2006 at Reel/Frame No. 3395/0746, Landis Plastics granted the Collateral Agent a security interest in and to all of its right, title and interest in its trademarks and all applications and registrations therefore, including goodwill as described more fully in the Security Agreement (the "Trademark Collateral");

WHEREAS, the Collateral Agent acknowledges that full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement have been made upon receipt of the funds described in the payoff letter dated the date hereof between Credit Suisse, Cayman Islands Branch and Landis Plastics, Inc.;

WHEREAS, Landis Plastics has requested that the Collateral Agent release its security interest in and to the trademarks and all applications and registrations therefore, including goodwill, set forth in Schedule A.


NOW, THEREFORE, on the basis of the foregoing, the Collateral Agent, without recourse, representation or warranty and at Landis Plastic's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the security interest granted to the Collateral Agent pursuant to the Security Agreement in each of the trademarks set forth in Schedule A attached hereto and incorporated herein by reference.

The Collateral Agent agrees to provide Landis Plastics with any information and additional authorization necessary to effect the release of the Collateral Agent's security interest in the Trademark Collateral.
