Assignor represents and warrants that as of the Effective Date, Assignor had not licensed, assigned or otherwise transferred any rights or interests in or to the Mark to any third party.

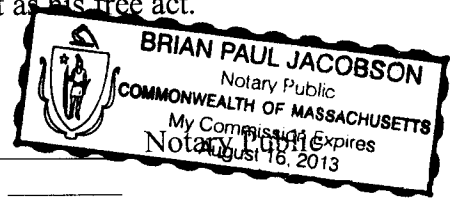

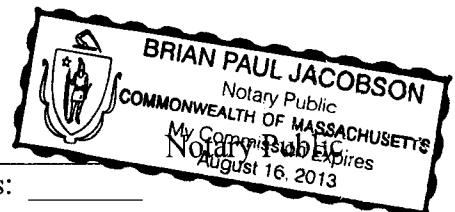
