## ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks (this “*Assignment*”) is made as of January 10, 2007 by CBS Radio Stations Inc., a Delaware corporation, and CBS Radio Holdings, Inc., a Virginia corporation (together, “*Assignors*”), to Wilks License Company-Kansas City LLC, a Delaware limited liability company (“*Assignee*”).

WHEREAS, Assignors, each with a place of business at 1515 Broadway, 46<sup>th</sup> Floor, New York, New York 10036, are the owners of registrations for the trademarks that are identified in Schedule A (“*Marks*”) on and in connection with the classes of goods/services as identified in Schedule A and desire to assign all of their right, title and interest in, to and under the Marks, together with the goodwill and business symbolized thereby; and

WHEREAS, Assignee, with a place of business at 3775 Mansell Road, Alpharetta, Georgia 30022, desires to obtain all of Assignors’ rights in, to and under the Marks; and

WHEREAS, pursuant to that certain Asset Purchase Agreement (the “*Purchase Agreement*”), dated as of October 10, 2006, among Assignors and Assignee and certain other parties, Assignors have agreed to assign all of their right, title and interest in, to and under the Marks to Assignee, and Assignee has agreed to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the terms and conditions of the Purchase Agreement, Assignors hereby sell, assign, transfer and convey to Assignee all of Assignors’ right, title and interest in, to and under the Marks, whether statutory or at common law, including all registrations and applications therefor, the right to recover for past infringement, and the goodwill associated with such Marks in the operation of the business of radio broadcast stations.

This Assignment is intended to evidence the consummation of the transactions contemplated by the Purchase Agreement and is subject to the terms and conditions set forth in the Purchase Agreement. This Assignment is made without representation or warranty, except as provided in or pursuant to the Purchase Agreement. Nothing contained in this Assignment shall be construed to supersede, limit or qualify any provision of the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Assignment and the terms and provisions of the Purchase Agreement, the terms and provisions of the Purchase Agreement shall govern.
