ASSIGNMENT OF TRADEMARK

Be it known that in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby assign to ASSIGNEE all worldwide right, title and interest in and to said TRADEMARKS, together with the goodwill of the business symbolized by said TRADEMARKS and the registrations thereof.

ASSIGNOR hereby further assign to ASSIGNEE (a) all damages and other proceeds hereafter recovered or received in any infringement suit, settlement or other proceeding related to the TRADEMARKS, (b) the right to sue for past, present and future infringements of the TRADEMARKS, and (c) all other rights corresponding to the TRADEMARKS and any existing or future applications and registrations related to the TRADEMARKS throughout the world.

ASSIGNOR further warrants that upon request of ASSIGNEE, it shall execute all documents, instruments and papers, make all rightful oaths, testify on behalf of ASSIGNEE and do all other lawful acts necessary to carry out the intent of this Assignment or to more fully evidence ASSIGNEE'S rights in the TRADEMARKS as well as to provide such other material, information and assistance as ASSIGNEE may consider necessary to carry out the intent of this Assignment.

ASSIGNOR further warrants that the TRADEMARKS assigned herein are in compliance with 37 C.F.R. Section 3.16, stating that ASSIGNOR is assigning any and all TRADEMARKS to register a mark under 15 U.S.C. 1051(b) to ASSIGNEE as successor to the applicant's business, or portion of the business to which the mark pertains, and the business is ongoing and existing.

ASSIGNOR covenants to and with ASSIGNEE that the ASSIGNOR is the owner and has the right to transfer and assign the TRADEMARKS, that the TRADEMARKS are free and clear of all liens, encumbrances and security interests, and that the ASSIGNOR will defend the title of the TRADEMARKS against any person claiming an adverse interest in the TRADEMARKS which interest arose prior to the date thereof.

The Assignment is binding upon the parties, their successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith. This

Assignment may be signed in counterpart and a signed facsimile copy shall have full force and effect as of the original.
