CERTIFICATE OF CONVERSION

CONVERTING

TICKETMASTER L.L.C.

(A Delaware Limited Liability Company)

TO

TICKETMASTER L.P.

(A Delaware Limited Partnership)

This Certificate of Conversion is being filed for the purpose of converting Ticketmaster L.L.C., a Delaware limited liability company (the "Converting LLC"), to a Delaware limited partnership to be named "Ticketmaster L.P." (the "Partnership") pursuant to Section 18-216 of the Delaware Limited Liability Company Act, 6 Del. C. §§ 18-101 et seq. (the "DLLCA"), and Section 17-217 of the Delaware Revised Uniform Limited Partnership Act, 6 Del. C. §§ 17-101 et seq. (the "DRULPA").

The undersigned, as an authorized person of the Converting LLC and the sole general partner of the Partnership, does hereby certify as follows:

1. Name of Converting LLC. The name of the Converting LLC under which its Certificate of Formation was originally filed and immediately prior to the filing of this Certificate of Conversion was "Ticketmaster L.L.C."

2. Date and Jurisdiction of Formation of Converting LLC. The date on which, and the jurisdiction where, the Converting LLC was formed, which jurisdiction has not changed, are as follows:

3. Name of Continuing Limited Partnership. The name of the Delaware limited partnership to which the Converting LLC is being converted and the name set forth in the Certificate of Limited Partnership of the Partnership filed in accordance with Section 17-217(b) of the DRULPA is "Ticketmaster L.P."

4. Approval of Conversion. The conversion of the Converting LLC to the Partnership has been approved in accordance with the provisions of Section 18-216 of the DLLCA and Section 17-217 of the DRULPA.

5. Effective Time. This Certificate of Conversion shall be effective upon its filing in the Office of the Secretary of State of the State of Delaware.
