**ARTICLES OF ORGANIZATION
FOR CONVERSION OF
FOREIGN LIMITED PARTNERSHIP TO A
LIMITED LIABILITY COMPANY**

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia (1950), as amended, the undersigned, on behalf of the limited partnership set forth below, states as follows:

1. The name of the former limited partnership is Ticketmaster L.P. (the "Company").
2. The date and place of filing of the initial certificate or statement of limited partnership or similar document of the former limited partnership:

3. The name of the limited liability company upon conversion is Ticketmaster L.L.C.

6. The limited liability company's principal office address, including the street and number, if any, is 8800 Sunset Boulevard, West Hollywood, California 90069.

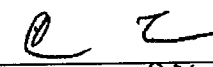
7. The terms and conditions of this conversion were approved by all of the partners.
