TRADEMARK COLLATERAL ASSIGNMENT

This TRADEMARK COLLATERAL ASSIGNMENT (this "Assignment") is made effective as of April 11, 2007, by JERGENS, INC., an Ohio corporation ("Jergens"), and ACME INDUSTRIAL COMPANY, an Illinois corporation ("Acme" and, together with Jergens, "Borrowers" and, individually, "Borrower"), in favor of NATIONAL CITY BANK, with an office located at 1900 East 9th Street, Cleveland, Ohio 44114 ("Bank").

1. As used herein:

1.1. "Collateral" means all general intangibles and all trademarks, registered or unregistered, of Borrowers, including but not limited to those listed on Exhibit A hereto, and all variations thereof, whether now or hereafter existing and whether designated as a trade name, trademark or service mark, all modifications thereto, all applications therefor, if any, all proceeds thereof (including license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements and all rights corresponding thereto, and the good will of each business to which they relate.

1.2. "Event of Default" means an Event of Default (as defined in the Credit Agreement) or a breach of or default under this Assignment.

1.3. Capitalized terms used in this Assignment without definition have the meanings ascribed to such terms in the Credit Agreement.

2. Borrowers request that Bank grant loans to Borrowers pursuant to the Credit Agreement and the Reimbursement Agreement and to grant such other financial accommodations to Borrowers as Borrowers may from time to time request and as Bank in each case may be willing to grant. In consideration thereof and for other valuable considerations, Borrowers hereby grant Bank a security interest in, and assign and convey to Bank, the Collateral as security for the Debt.

18. BORROWERS WAIVE ANY RIGHT TO HAVE A JURY PARTICIPATE IN RESOLVING ANY DISPUTE, WHETHER SOUNDING IN CONTRACT, TORT OR OTHERWISE, BETWEEN BANK AND BORROWERS, ARISING OUT OF, IN CONNECTION WITH, RELATED TO, OR INCIDENTAL TO THE RELATIONSHIP ESTABLISHED BETWEEN THEM IN CONNECTION WITH THIS ASSIGNMENT OR ANY NOTE OR OTHER INSTRUMENT, DOCUMENT OR AGREEMENT EXECUTED OR DELIVERED IN CONNECTION THEREWITH OR THE TRANSACTIONS RELATED THERETO. THIS WAIVER SHALL NOT IN ANY WAY AFFECT, WAIVE, LIMIT, AMEND OR MODIFY BANK'S ABILITY TO PURSUE REMEDIES PURSUANT TO ANY CONFESSION OF JUDGMENT OR COGNOVIT PROVISION CONTAINED IN ANY NOTE OR OTHER INSTRUMENT, DOCUMENT OR AGREEMENT EXECUTED AND DELIVERED BY BORROWERS TO BANK.
