
WHEREAS, Assignee desires to acquire the entire right, title and interest in and to the Trademarks in the United States.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. A party's signature may be transmitted by facsimile, thereby constituting a signed and delivered document.




