TRADEMARK ASSIGNMENT


The Glickman Group, a California limited liability company, located at 88 Lombardy Lane, Orinda, California 94563, and Ron Glickman, its "assigned signatory," (collectively "Glickman") on March 16, 2004 filed a federal trademark application, Serial No. 78/384,967, for the designation TRANSFORMING WHILE PERFORMING for use for change management consulting for businesses. The claimed first use date in interstate commerce in the application was October 1, 2002. This federal trademark application registered on December 28, 2004, Registration No. 2,935,079.

For good and valuable consideration, receipt of which is hereby acknowledged, Glickman assigns to Cognizant Technology Solutions Corporation ("Cognizant"), a Delaware corporation, with its principal place of business at 500 Glenpointe Center West, Teaneck, New Jersey 07666, all its right, title and interest, including any common law rights, in and to the designation TRANSFORMING WHILE PERFORMING ("Designation") for change management consulting for businesses, or any other goods or services, together with the goodwill of the business symbolized by the Designation to the full extent that it exists, and the above identified registration, Registration No. 2935079 ("Registration"). This assignment includes the right to sue and recover damages for past and future infringements of any of Glickman's rights in the Designation and Registration, and to bring and defend any proceeding in the United States Patent & Trademark Office, or in any other jurisdiction, for cancellation or opposition or other proceeding in connection with the Designation and Registration. The right, title and interest in the Designation and Registration is to be held and enjoyed exclusively by Cognizant and Cognizant's transferees, successors and assigns as fully and exclusively as it would have been held and enjoyed by Glickman had this assignment not been made.

Glickman acknowledges that by virtue of this assignment it will have no right to use or hold any rights in the Designation or the Registration in any format, or any confusingly similar designation, name, brand, domain name or mark for any purpose, or hold any right to interfere with, directly or indirectly, with Cognizant's rights in the Designation and Registration. The assignment and its terms and conditions will be fully binding on Glickman and any of its employees, signatories, agents, principals, representatives, transferees and successors.

Glickman further agrees that it will execute, verify, acknowledge and deliver all such further documents, including any instruments necessary for recordal of this assignment, and perform such other acts as Cognizant lawfully may request, from time to time, to perfect and vest title in the Designation and Registration in Cognizant or Cognizant's successors, transferees and/or assigns.
