**RELEASE OF SECURITY INTEREST IN TRADEMARK**

**Mark: SLEEPWELL 2-NITE, Reg. No. 1,441,613 for non-prescription sleep inducing aid**

Releasor agrees that this Release of Trademark Security Interest may be recorded with the U.S. Patent and Trademark Office, at Owner's sole cost and expense. Releasor agrees to execute any other documents that may be required to release any interest Releasor may have in the Mark.
