**RELEASE UNDER  
PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT**

THIS RELEASE UNDER PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT ("Release") is made as of March 30, 2007, by and between CALIFORNIA WHOLESALE MATERIAL SUPPLY, INC., a California corporation ("Borrower"), and UNION BANK OF CALIFORNIA, N.A., as agent (in such capacity, "Agent") for lenders ("Lenders") from time to time party to that certain Loan and Security Agreement dated as of November 26, 2003, by and among Borrower, Agent and Lenders.

Agent and Borrower previously entered into a Patent, Trademark and Copyright Security Agreement (the "Trademark Security Agreement") dated as of November 26, 2003, pursuant to which Borrower granted a security interest to Agent, for the benefit of Agent and Lenders, in the trademark listed in **Appendix A** hereto, which Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 5, 2003, at Reel/Frame 002758/0490.

(b) Governing Law. THIS RELEASE SHALL BE GOVERNED BY AND INTERPRETED, CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CALIFORNIA.
