TRUSTEE'S MOTION FOR APPROVAL OF SETTLEMENT AGREEMENT

COMES NOW John C. Reed, Trustee in the above identified Chapter 7 Bankruptcy Proceeding, and hereby moves this Court to enter its Order approving a comprehensive settlement as described herein.

1. Debtors filed this Chapter 7 bankruptcy proceeding on March 20th, 2006, and John C. Reed is the duly appointed and acting Trustee herein.

2. Debtors have been active in the creation, design, production and marketing of specialty food sauces both individually and acting through two entities known as Eat Me, LLC and The Family Jewels, LLC. Debtor Joseph Johno also owns stock in Ozark Mountain Specialty Foods, Inc.

3. In connection with their food business the Johnos have also had transactions with John Burt, a businessman in Nebraska, who is the owner of Bar B Que Specialties, Inc., and an owner of stock in Ozark Mountain Specialty Foods, Inc.

4. There is pending a lawsuit in the United States District Court for the District of Nebraska captioned *Ozark Mountain Specialty Foods, Inc. v. Eat Me, LLC and Sandra Johno*, Case Number:8:04CV349.
