This Amendment to Articles of Incorporation was adopted on March 15, 2007.

This Amendment to Articles of Incorporation will be effective upon filing by the Secretary of State.

This Amendment to the Articles of Incorporation received a majority vote of the directors on March 14, 2007. There are no members of the corporation with voting rights.

Article 1 of the Articles of Incorporation is amended to read as follows:  
**ARTICLE 1. NAME**

The name of this corporation is: **MADREMONTE FOUNDATION.**

Article 2 of the Articles of Incorporation is amended to read as follows:  
**ARTICLE 2. DURATION**

The duration of the corporation is perpetual.

Article 3 of the Articles of Incorporation is amended to read as follows:  
**ARTICLE 3. PURPOSES**

The corporation is organized exclusively for educational, charitable, religious, scientific and/or literary purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as may be amended from time to time (the "Code"), including promotion of the educational mission of the Society of Jesus, particularly with respect to sustainable economic development and relief of poverty, including programs of education as well as through programs of financial assistance and other aid designated to improve economic conditions and economic opportunities in impoverished areas, and making grants to qualified organizations.

Article 4 of the Articles of Incorporation is amended to read as follows:  
**ARTICLE 4. PROHIBITED ACTIVITIES**

Notwithstanding any of the provisions of these Articles of Incorporation, the corporation shall not conduct or carry on activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Code or by an
