### AMENDED AND RESTATED TRADEMARK COLLATERAL AGREEMENT

This 31<sup>st</sup> day of July, 2006, FITNESS QUEST INC., a Delaware corporation ("Debtor") with its principal place of business and mailing address at 1400 Raff Road S.W., Canton, Ohio 44710, in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, mortgages and pledges to Comerica Bank ("Comerica"), with its mailing address at One Detroit Center, Detroit, Michigan 48226, acting as administrative agent hereunder for the Secured Creditors as defined in that certain Security Agreement hereinafter defined (Comerica acting as such administrative agent and any successor or successors to Comerica acting in such capacity being hereinafter referred to as the "Agent") and grants to the Agent for the benefit of the Secured Creditors, a continuing security interest in, the following property:

- (i) Each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and
- (ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and
- (iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages;

to secure performance of all Secured Obligations (as such term is defined in the Security Agreement defined below) of the Debtor and the other debtors as set out in that certain Security Agreement dated as of October 20, 2004 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and among the Debtor, the other debtors party thereto, and the Agent (executed by its predecessor as Agent, Harris Trust and Savings Bank). The Debtor and the Agent acknowledge and agree that the agreements previously filed with the United States Patent and Trademark Office against the property of the Debtor set forth herein secure the performance of all Secured Obligations of the Debtor and the other debtors set forth in the Security Agreement. The Agent shall not proceed with filings not in compliance with Section 8.2 of the Credit Agreement.

As permitted by Section 12.11 of the Credit Agreement, and as promptly as practicable following receipt of notice from the Debtor of the sale, disposal, termination or expiration of any trademark, trademark application or trademark license set forth on Schedule A-1 or Schedule A-2 hereto, the Agent shall execute a release of security interest in trademarks, in form and substance reasonably satisfactory to the Debtor, through which the Agent releases its security

interest in such trademark, trademark application or trademark license and the Agent shall file such release of security interest in trademarks with the United States Patent and Trademark Office. Promptly following the filing of such release of security interest in trademarks, and receipt by the Agent of the official notice of recordation from the United States Patent and Trademark Office (evidencing receipt and recordation of the release of security interest in trademarks and referencing the recordation date and reel/frame number of the recordation) (the "Release Documents"), the Agent shall provide copies of the Release Documents to Debtor.

Notwithstanding anything herein to the contrary, this Trademark Collateral Agreement shall not operate as a sale, transfer, conveyance or other assignment to Secured Party of any applications by Debtor for a Trademark based on an intent to use the same if and so long as such application is pending and not matured into a registered Trademark (such pending applications which are based on intent to use being hereinafter referred to collectively as "Intent-To-Use Applications"), but rather, if and so long as Debtor's Intent-To-Use Application is pending this Trademark Collateral Agreement shall operate only to create a security interest for collateral purposes in favor of Secured Party on such Intent-To-Use Application as collateral security for the Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the mortgage, pledge and security interest in the trademarks, trademark registrations, trademark applications and trademark licenses made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

All terms defined in the Security Agreement, whether by reference or otherwise, when used herein, shall have their respective meanings set forth therein, unless the context requires otherwise.

This Agreement amends and restates that certain Trademark Collateral Agreement dated as of October 20, 2004 (the "Original Trademark Collateral Agreement") by the Debtor for the benefit of the Agent (executed by its predecessor as Agent, Harris Trust and Savings Bank). Liens previously evidenced by the Original Trademark Collateral Agreement continue in effect under this Agreement.


