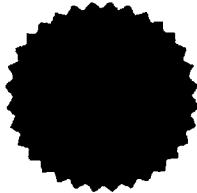

This Certificate of Conversion to Limited Liability Company, dated as of June 29, 2006, is being duly executed and filed by National Mentor, Inc., a Delaware corporation (the "Company"), and Linda DeRenzo, as an authorized person of National Mentor Holdings, LLC, a Delaware limited liability company, to convert the Company to National Mentor Holdings, LLC under the Delaware Limited Liability Company Act (6 Del. C. § 18-101 *et seq.*) and the General Corporation Law of the State of Delaware (8 Del. C. § 101, *et seq.*).

1. The Company filed its original certificate of incorporation with the Secretary of State of the State of Delaware on December 16, 1993, and continued to be incorporated in the State of Delaware immediately prior to the filing of this Certificate of Conversion to Limited Liability Company.
2. The Company's name immediately prior to the filing of this Certificate of Conversion to Limited Liability Company was National Mentor, Inc.
3. The name of the limited liability company into which the Company shall be converted as set forth in its certificate of formation is "National Mentor Holdings, LLC."
4. The conversion of the Company to National Mentor Holdings, LLC shall be effective upon filing this Certificate of Conversion to Limited Liability Company and a certificate of formation of National Mentor Holdings, LLC with the Secretary of State of the State of Delaware.
5. It is intended that the conversion of the Company to National Mentor Holdings, LLC will qualify as a tax-free liquidation under Section 332 of the Internal Revenue Code of 1986, as amended.
