RELEASE OF SECURITY INTEREST
IN TRADEMARKS

For good and valuable consideration, receipt of which is hereby acknowledged, Wells Fargo hereby releases, retransfers and reassigns to TPC, without representation or warranty of any kind, express or implied, all of Wells Fargo's right, title and interest in and to the Released Marks and the goodwill associated therewith.
