ASSIGNMENT OF TRADEMARK

WHEREAS, Assignor confirms that other than the rights claimed by Assignee, Assignor is aware of no other claimants to any rights, title, and interest in the said Mark, the pending Application, and/or that portion of Assignor's business in connection with which it has a *bona fide* intent to use the said Mark; and

WHEREAS, Assignor represents that Assignor will not make any further assignments of the rights, title, or interest in the said Mark, the pending Application, and/or that portion of Assignor's business in connection with which it has a *bona fide* intent to use the said Mark;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged,

1. Subject to the terms of the Settlement and Mutual Release Agreement between Assignee and Assignor, dated March 2, 2007, Assignor does hereby assign, sell and transfer unto Assignee all worldwide right, title and interest in and to the said Mark, together with (a) the pending Application for said Mark and (b) that portion of Assignor's business in connection with which it has a *bona fide* intent to use the said Mark.

2. Assignor agrees to perform any further acts and execute and deliver any documents, each, at Assignee's expense, that may be reasonably necessary to carry out the provisions of this assignment.

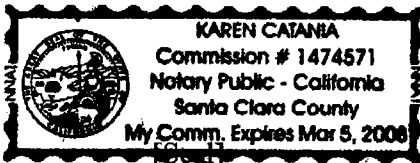
