## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made on the 10<sup>th</sup> day of April, 2007 by PNC BANK, NATIONAL ASSOCIATION, with an office at 2 North Lake Avenue, Suite 440, Pasadena, California 91101, in its capacity as collateral agent for and on behalf of itself and certain other financial institution ("Secured Party").


