TRADEMARK ASSIGNMENT AGREEMENT

This Agreement, effective April 9, 2007 ("Effective Date"), is by and between **Chicago 2016 Exploratory Committee**, an Illinois not-for-profit corporation ("Assignor"), and the **United States Olympic Committee**, a Congressionally chartered non-profit corporation (the "USOC").

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark **CHICAGO 2016** (word mark) (the "Trademark"), including, but not limited to, U.S. Trademark Serial Number 77/052,430, as well as all common law rights and goodwill of the business symbolized by said Trademark as used in connection with organizational and promotional services in connection with the sponsorship and support of educational, cultural, business and sporting and athletic activities related to the host city selection process for international athletic events.

WHEREAS, USOC is desirous of acquiring said Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to the USOC, its successors, assigns and legal representatives, all right, title and interest in and to the Trademark, together with the goodwill of the business symbolized thereby, all rights to sue for past infringement of said Trademark, and all causes of action (either at law or equity) with respect thereto, the right of recovery, including but not limited to damages, for such past infringement, and the right to assign or license the rights conveyed herein, the same to be held and enjoyed by the USOC for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.

Assignor hereby authorizes the USOC to record ownership of the Trademark directly in the USOC's own name in any jurisdiction, municipality, or agency, in which

recordation is required.

Assignor will from time-to-time after the Effective Date, upon request of the USOC, execute, acknowledge, and deliver all such further deeds, assignments, transfers, conveyances, powers of attorney and assurances, and take such further action as may be required to carry out the intent of this Assignment, and to transfer and vest title to any trademark being transferred hereunder, and to protect the right, title, and interest in and enjoyment of all the Trademark assigned hereunder.
